Waste Trends and Regionalisation

Australia generates 48 MT/year of waste (latest National Waste Data Report 2014). In the period 1997-2012 our population rose by 22% but waste generation increased by 145%. There are more of us and we generate more waste per person, each year.

On the positive side, recycling is growing at a faster rate and since 2005 we have actually seen (for the first time) a decline in tonnages of waste sent to landfill (in the most progressive States). We now recycle approximately 52% of all the waste we generate and landfill the rest.

The consolidation of regional landfills via conversion into transfer stations can realise significant cost savings and environmental benefit. Consolidation of these landfill assets is an easy win in terms of cost reduction and environmental improvement.

The \$7 million Landfill Consolidation and Environmental Improvements grants are part of the NSW Government five year \$465.7 million Waste Less, Recycle More initiative to support local communities reduce waste and increase recycling. Diverting mattresses from landfill

Developed in response to a shortage of entry level positions for people with barriers to employment, Softlanding is a \$3.6million mattress recycling business located in NSW. The business' primary purpose is to create a positive social impact

via generating employment opportunities for those excluded from the open labour market. To date over 200 staff have been employed within Softlanding.

Softlanding has attracted strong support and engagement with commercial retailers and manufacturers which are looking to Mission Australia to lead a national solution to mattresses being diverted from landfill.

Waste Aid Program

Waste Aid, is a registered charity, established in 2014 that aims to improve public health, environmental and social outcomes in disadvantaged and remote communities through positive waste management solutions. The NSW EPA has engaged Waste Aid to develop the first ever state strategy for managing waste in Aboriginal communities. They are seeking to consult with councils, contractors and communities and are piloting a new sustainable waste management model in Bourke and Enngonia communities.

Community Recycling Centres – the experience of North East Waste

NE Waste secured funding for 5 CRCs in the first round of Waste Less Recycle More and 3 CRCs in Round 2. This presentation highlights some of the challenges and opportunities the project has delivered from an operational and administrative perspective. It will focus on how those embarking on a CRC project can avoid or overcome some of these challenges and deliver positive outcomes.

Product Stewardship update, thoughts and learnings

Product stewardship presents a significant opportunity for producers and manufacturers to take responsibility for their endof-life products to ensure they are managed in a safe and sustainable manner. With the commencement of the Product Stewardship Act 2011 there is now a legislative framework to shape voluntary, co-regulatory and mandatory product stewardship schemes across Australia. Recently there has been significant movement in this space with the review of the television and computers' scheme, the commencement of a voluntary scheme for end-of-life tyres and progression on new schemes for paint and batteries.

The presentation will provide an update on where these schemes are up to and delve into the challenges faced by stakeholders, particularly local government in engaging with and shaping these schemes and their on-the-ground implications.

In addition to this work at the national level, the NSW Government also recently announced that it would implement a state-wide container deposit scheme. The Government has committed to a commencement of the Scheme by 1 July 2017 with broad consultation on its design to take place in 2016.
